


## CHILD PROTECTION



#### Less talked about: Clergy sexual abuse on the mission field



While Southern Baptists have been focused on alleged mishandling of sexual abuse cases in the United States, there's another, less-talked-about legacy of sexual abuse perpetuated by Christian missionaries sent from the United States to other countries.

As one of the largest missionary-sending denominations in the world, the Southern Baptist Convention has played a role in this unspoken drama, although the SBC is far from alone in addressing problems created by a relatively small number of wayward missionaries

Malawi, one of the world's least-developed nations, has a history of Western mission behaving unethically with children under their care. This has happened against the backdrop of American and European missionaries lavishly helping out with adoptions, education and health care in the southeast African nation



# THE WARM HEART OF...?


- 25% of all children in Malawi experienced multiple forms of violence.
- 20% of females and 14% of males in Malawi experienced sexual abuse before the age of 18, with 68.4% of them experiencing multiple incidents of sexual abuse.
- Among those who had their first sexual intercourse prior to age 18, one-third of females were forced or coerced.
- In the 12 months preceding the survey, nearly 20% of girls experienced at least one incident of sexual abuse, with over three-quarters of them reporting multiple incidents.

# WHAT HAS PATRIARCHY TO DO WITH THIS?

- Gender biases among young adults aged 18 to 24:
  - 90% of females and 80% of males endorsed one or more gender biases.
- Commonly endorsed gender biases:
  - Men should decide when to have sex ('endorsed' by Malawi's legal definition of the marital rape is archaic).
  - Men need more sex than women.
  - Men need other women.
  - Women should tolerate violence to maintain relationships (and in parts this is celebrated).
- Malawi is predominantly a patriarchy (Malawi Government, 2016)



Malawians aged 13 to 24 years believe a woman should tolerate violence to keep the family together.

# How can technology BE HARNESSED?

- Child-centred and user friendly support, reporting and information portal
  - Less than 3% (13-17 years) and 10% (18-24 years) received professional support among the two-thirds who disclosed their abuse.
- Multisectoral & cross-country collaborative (AU, EU, UN) – a sex offenders' register; what happens when the 2100 are released?
- Social media companies the focus has been more on the global north.
